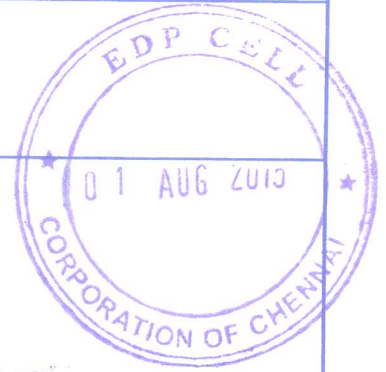

**Notice inviting request for proposal (RFP)**

The Superintending Engineer, Storm Water Drain Department, Corporation of Chennai, invites Request for Proposal (RFP), from the interested bidders for sponsoring one Environmental Specialist and one Social Safeguard Specialist for a period of TWO YEARS for assisting the Corporation of Chennai (COC) in implementing Environment Management Plan and Resettlement Action Plan (Plan) drawn for the resettlement of the Project Affected Families (PAFs) of the project area, relating to the Integrated Storm Water Drain Project (ISWD) in Cooum and Adyar basins, funded by the World Bank under Tamil Nadu Sustainable Urban Development Project (TNSUDP).

The term and conditions for submission, of proposal is more elaborately detailed in the RFP document.

The Pre-qualification for the bidder is as follows:

1. The Bidder shall have experience in having hired out the services of Environmental and Social Safeguard Specialists to at least 5 reputed Organization or 3 Government organization at least one specialist per organization in the past 5 years (2014-15 to 2010-11) and performance certificate to the effect obtained from the client shall be furnished along with the RFP. The period of sponsoring the professionals which is more than 1 year shall only be considered and the consolidated contract period for the past 5 years (2014-15 to 2010-11) shall not be less than 10 years. The details of the sponsoring of the professional shall be submitted in Form No.2.
2. The bidder shall have an average annual turnover minimum of Rs.5.00 Crores (Rupees Five Crores only) per annum in the last three financial years commencing from April to March, in hiring out of Manpower only, and a certificate to the effects shall be produced from their auditor.
3. The bidder shall enclose a sum of Rs.3,36,000/- (Rupees three laksh thirty Six thousand only) towards Earnest Money Deposit (EMD) by means of Crossed Account Payee Demand Draft drawn in favour of Commissioner, Corporation of Chennai obtained from the Scheduled Bank, Or by means of irrevocable bank guarantee, in favour of Commissioner, Corporation of Chennai, obtained from a Scheduled Bank, the validity period of which shall be 30 days beyond the period of validity of the RFP.

The Proposals received without EMD will be summarily rejected.

The Proposal shall be unconditional. The conditional Proposals will be rejected summarily.
