Other Terms and Conditions

- a) The minimum period to be served for this position 2 years adhering to the contractual norms of National Health Mission - TN (Contract being renewed after completion of every 11 months subject to performance appraisal)

- b) The continuance of the contractual services engaged for the purpose shall not be entertained beyond the end date of the TN-RIGHTS projects.
- c) However, provision of any contractual positions commensurate to their qualification beyond the TN-RIGHTS projects period shall be subject to discretion of DHS Officer.
- d) In case of selection, the contract appointment will be subject to medical fitness and verification of character and antecedents.
- e) The selected candidates will have to join duty immediately or on the date indicated in the offer of appointment within 3 working days.
- f) An absence from work for a period of five days without prior permission of the competent authority will amount to voluntary abandonment of engagement and may result in automatic termination.
- g) Once recruited/contracted for a Special Educator for Behavioral Therapy , Occupational Therapist and Social worker post , prior notice of 30 days is mandatory for resignation.

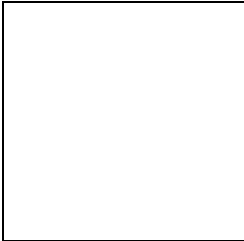
